# MATH4GOOD APPLICATION LICENSE AGREEMENT

This Application License Agreement ("<u>Agreement</u>") is an agreement between your company ("<u>Licensee</u>") and AIMMS B.V. and its affiliates ("<u>AIMMS</u>") for the Software (as defined below). By accessing or using the Software or by clicking on "accept" Licensee agrees to comply with and be bound by the terms of this Agreement and Licensee represents it has the authority to enter into this Agreement. If Licensee does not agree to the terms of this Agreement, it must not access or use the Software. This Agreement shall govern Licensee's access and use of the Software as of the Effective Date.

## 1. Definitions

"Software" means the software product for which Licensee has acquired the right to use from AIMMS after the Effective Date.

"Documentation" means materials, in written or other tangible form that AIMMS may provide or make available on or after the Effective Date that describe the Software's functional or technical specifications.

"Effective Date" means the date when any instructions, user ID's, software license keys or passwords are made available by AIMMS to Licensee that enables Licensee to activate or access the Software.

# 2. Right to Use

2.1 AIMMS grants to Licensee a limited, non-exclusive, non-sublicensable, non-transferable, revocable licence during the term of the Agreement to access and use the Software solely for internal, non-profit business purposes and not for any other purpose, including but not limited to commercial purposes.

2.2 The Software and associated Documentation, specifications and features are subject to change at any time with or without notice.

2.3 The "fair use" principle applies with respect to the use of the Software. Licensee may process unlimited data within the Software, however, if the amount of data processed by Licensee is no longer considered reasonable by AIMMS, for example if this causes a disproportionate load on the server, AIMMS will consult with Licensee to find a suitable solution. Whether the 'fair use' principle is met is at the sole discretion of AIMMS.

## 3. Intellectual Property Rights

3.1 All right, title and interest in and to the Software and Documentation made available by AIMMS to the Licensee pursuant to this Agreement, including without limitation, all intellectual property rights therein, shall remain exclusively with AIMMS and/or its licensors, as applicable.

## 4. Prohibitions

4.1 Licensee shall not (i) modify, copy or create derivative works based on the Software; (ii) frame or mirror any content forming part of the Software, other than on Licensee's own intranets or otherwise for its own internal business purposes; (iii) reverse engineer the Software; (iv) access the Software in order to (a) build a competitive product or service, or (b) copy any ideas, features, functions or graphics of the Software; (v) use the Software for any purposes except as expressly provided in this Agreement; or (vi) allow any third party to access or use the Software for any reason.

## 5. Fees

5.1 The use of the Software as described in this Agreement is free of charge, subject to Licensee's compliance with section 2.3.

## 6. Term and Termination

6.1 This Agreement commences on the Effective Date and shall continue indefinitely unless earlier terminated in accordance with section 6.2 below.

6.2 Each party may terminate this Agreement at any time with or without notice. This Agreement and the license granted therein will automatically terminate in the event that Licensee has not used or accessed the Software for a continuous period of three (3) months, in which case Licensee needs to request a new license for the Software.

6.3 Upon termination, Licensee shall immediately cease using the Software and delete all copies of the Software residing on the computers, networks and/or systems of Licensee. At the request of AIMMS, Licensee shall certify that the terms of this section have been complied with.

6.4 Licensee acknowledges and agrees that should Licensee desire to continue to use the Software for any purpose other than as authorised herein, such as for profit or commercial purposes, it shall be required to enter into a standard AIMMS commercial Software License or Hosted Services Agreement and to the payment of applicable fees for such use.

## 7. No Warranty; Disclaimer of Liability

7.1 The Software and Documentation are provided "AS IS", without any warranty of any kind, express or implied, including but not limited to any warranty or representation that the Software or Documentation will meet Licensee's requirements or that the operation thereof or access thereto will be error free. To the greatest extent allowed by applicable law, AIMMS specifically disclaims all implied warranties and representations of quality, fitness for a particular purpose or non-infringement of third-party rights, except to the extent that any warranties or representations implied by applicable law cannot be validly waived.

7.2 In no event shall AIMMS or any of its affiliates be liable for any direct, indirect, consequential, incidental, special, punitive or other damages whatsoever, arising out of or related to this Agreement even if AIMMS or its affiliates have been advised of the possibility of such damages. AIMMS reserves the right to discontinue the availability of the Software, or modify it, at any time, without obligation to anyone.

7.3 AIMMS disclaims all warranties and liabilities arising from or related to any third-party products or services, or open-source products (regardless of whether obtained from AIMMS or another source).

# 8. Support Services

8.1 Technical and/or functional support services for the Software are provided to Licensee via an online user group provided by the AIMMS online community, which may be accessed via the Software or via the details provided in the email message received by Licensee upon activation of the Software. AIMMS shall use reasonable efforts to respond to any support request within two (2) business days.

# 9. Indemnification

9.1 Licensee shall indemnify, defend and hold AIMMS harmless from and against any and all losses, damages, costs and expenses (including reasonable attorneys' fees) incurred by it in connection with third party claims made or brought against AIMMS involving a breach of this Agreement by Licensee.

# 10. Applicable Law and Forum

10.1 This Agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including noncontractual disputes or claims) shall be governed by and construed in accordance with Dutch law and each party hereby submits to the exclusive jurisdiction of the Dutch courts. The United Nations International Convention on Contracts for the International Sale of Goods is expressly excluded from applicability to this Agreement.

## 11. Export Compliance

11.1 Licensee shall comply with all applicable export compliance requirements including applicable US and European export laws and regulations and those of other relevant foreign jurisdictions. Licensee shall not use or access the Software in a EU or US embargoed country or in violation of any EU or US export law or regulation. Licensee warrants and represents that it is not named on any government denied-party list.

## 12. Miscellaneous

12.1 This Agreement constitutes the entire agreement between the parties, superseding all prior oral or written representations, agreements or understandings with respect to the subject matter hereof and thereof. There are no representations, warranties, conditions, guarantees or agreements relating to such subject matter except those expressly stated in this Agreement.

12.2 This Agreement is personal to Licensee, and Licensee may not sell, transfer, assign or otherwise convey this Agreement, or any of Licensee's rights or obligations hereunder without the prior written consent of AIMMS.

12.3 Licensee agrees that certain breaches of this Agreement by it may result in irreparable harm to AIMMS, the extent of which would be difficult and/or impracticable to assess, and where money damages would not be an adequate remedy for such breach. Accordingly, AIMMS shall be entitled to seek any and all remedies available at law or in equity, including without limitation injunctive relief or specific performance.

12.4 If any provision of this Agreement, or the application of any provision to any party or circumstance, is held invalid, the remainder of this Agreement, and the application of the provision other than to the extent it is held invalid, will not be invalidated or affected.

12.5 The terms and conditions of this Agreement may be changed by AIMMS at any time, with or without prior notice.

12.6 No one other than a party to this Agreement shall have any right to enforce any of its terms.
